

Hey, Do We Have Your Money?

Every year, KIUC publishes a list of members to whom we owe a patronage capital return. Patronage capital is the money KIUC has left after paying all of its expenses in a given year. At the end of the year, that money is credited to each member's patronage capital account, according to the amount paid for electricity used.

In past years, KIUC issued retirement checks to members, so it's possible some of those on the list forgot to cash the check or accidentally threw it away. If your name appears on the list, you must apply for a return. Please complete the form below and provide a copy of picture ID as proof the person requesting the return is the same as the account holder. You can mail the form or bring it to our office. If you need additional forms, download one from our website at www.kiuc.coop.
