Eligibility Requirements / Terms & Conditions

1. Rebate applications must be submitted no later than one month after appliance purchase.
2. Members must purchase at minimum 300 kWh per month of electricity from KIUC for the preceding 12 months prior to rebate submission.
3. Rebate incentives are limited to one rebate for each eligible appliance per household and account holder must purchase appliance.
4. Rebates will be paid for replacement of existing appliances only. New appliances for newly built homes are ineligible.
5. Rebates are limited to Residential Customers. Commercial Entities, Commercial Customers and Residential New Construction do not qualify.
6. Participation is based on a first-come, first-served basis.
7. KIUC reserves the right to discontinue or change the rebate levels without notice.
8. **Participants must complete a rebate application and submit it along with a copy of a detailed purchase receipt, and an approved county permit number to: KIUC ENERGY SERVICES, 4463 Pahee St., Suite 1, Lihue, HI 96766-2000 or email to energyservices@kiuc.coop .**
9. Approved County Permit number must be provided to be eligible for Rebate.
10. Qualifying rebates will be credited to the above referenced account within 3 to 6 weeks from the date approved.
